You may be selected for Jury Service Jury Service plays a central role in our NSW justice system





If you are randomly selected as a juror, you are given the opportunity to provide an important community service.

### **About the Notice of Inclusion**

The attached Notice of Inclusion is to advise you that your name has been randomly selected from the New South Wales electoral roll and included on a list of potential jurors known as a Jury Roll.

People listed on a Jury Roll may be summoned for Jury Service over the next twelve months.

Please read the Notice of Inclusion carefully.

You do not need to reply to the Notice unless you need to:

- advise the Sheriff of a change in your personal details, such as a change of name or address
- request that your name be removed from the roll.

If you do need to reply, the fastest way is online at **juror.nsw.gov.au** 

# Should your name be removed from the Jury Roll?

Certain categories of people are excluded from serving on a jury and others can ask to be excluded. You must include documented proof if you apply to be removed from the Jury Roll.

# If you have an age related issue

You may seek to be removed from the roll under the provision of 'Good Cause'.

## You may be selected for Jury Service

If your name is not taken off the Jury Roll you may receive a Jury Summons asking you to serve on a jury.

The Jury Summons will ask you to attend a Court in your local district. If you receive a summons you will have an opportunity to play an active role in the administration of justice.

You will receive more information about the jury process and the responsibilities of a juror if you receive a Jury Summons.

# If you have holidays, exams or other commitments

You can let us know about dates that would make it difficult for you to serve, by visiting **juror.nsw.gov.au**, or by calling 1300 722 574. You can nominate up to two periods, to a total of up to 2 weeks each.

# Criminal and civil trials

You may be requested to attend Jury Service for a criminal trial or a civil trial in NSW.

In a criminal trial the jury's function is to hear evidence, apply the law as directed by the Judge and decide if a person is guilty or not guilty of a crime. In civil trials the Judge will outline the issues the jury needs to decide.

Usually civil trials are about defamation proceedings.
